City Education Grant

Terms & Conditions for 2024/25 academic year of entry

- 1. Students must meet the eligibility criteria set for the City Education Grant as follows:
 - 1. Ordinarily resident in England;
 - 2. New full-time entrants to City starting their first year in 2024/25 of an
 - 3. undergraduate degree course BA, BSc and BEng;
 - 4. Not already been awarded a degree;
 - 5. Household income of zero as assessed by Student Finance England (SFE) and shared with City before/on 31st October 2024.
- 2. Eligible students must be registered at City by 31st October 2024. Both student and sponsor (if applicable) must give consent to share their household income information with City, University of London by 31st October 2024 via Student Finance England (SFE). Students' financial information shared from 1st November 2024 onwards will not be accepted and the student will not be considered for a City Education Grant for the full duration of their undergraduate course; this includes transferring to a new undergraduate course at City.
- 3. Students must be new entrants to City and have not already been awarded a degree.
- 4. Students must be starting the first year of their degree as a new student (i.e. those starting in Year 2, Year 3 and Year 4 are not eligible).
- 5. The grant is available to undergraduate students who are ordinarily resident in England. Students who normally live in Scotland, Wales or Northern Ireland are not eligible.
- 6. Students whose tuition fee status' are reassessed in the middle of their degree or who restart a degree will not be eligible.
- 7. Students can only receive one of the following awards: City Education Grant, City Cares Award or Sanctuary Scholarship.
- 8. Where students' enrolment statuses change from full-time enrolled to dormant, suspended, part-time or withdrawn the next instalment of the grant will be cancelled and any payment already received may need to be repaid by the student to City.
- 9. The grant is payable for a maximum of three years and will be paid in two instalments in January and April each academic year. Students must remain eligible to receive the grant during 2024/25 and during each subsequent academic year. Students must be enrolled full-time to receive the grant in 2024/25 and each subsequent year. Students' household data must be

shared with City by 31st October in each subsequent academic year. The student household income as assessed by Student Finance England (SFE) must remain as zero to retain eligibility.

- 10. The grant will not be paid during part-time or full-time repeat academic years, dormant/suspended periods, during a placement year or study aboard year.
- 11. The following categories of students are not eligible:
 - 1. Students directly continuing from one course to another (for example,
 - 2. from a foundation degree or HND on to the final year of an honours
 - 3. degree);
 - 4. Students transferring in from another institution;
 - 5. Students undertaking a postgraduate qualification or short courses;
 - 6. Part-time students studying at less than 25 per cent intensity of the full-
 - 7. time equivalent course.
