

QAA Subject Benchmark Update

The Quality Assurance Agency (QAA) publishes benchmark statements setting out expectations about standards of degrees in a range of subject disciplines. The benchmark statements are a key reference point in programme development and review.

The QAA are in the process of producing new and revised benchmark statements for some subjects. They are invite stakeholders to contribute to the revision process for existing statements; a schedule outlining the phases of the review has been published.
